Whereas, Much of this material features crime, sex, gambling, and total disregard of the law; and

Whereas, The General Federation of Women’s Clubs – New Hampshire believes such programs and material contribute to the development of juvenile delinquency; therefore

Resolved, That the General Federation of Women’s Clubs – New Hampshire urges its member clubs to combat such programs and material through cooperative community action programs, and to work for the enforcement of legislation which will prevent such presentation to the public, with fines and punishment for violators.

Support of Arts in Schools and Communities

Whereas, The arts enhance life in all its dimensions; and

Whereas, Art serves as a vehicle for communication not always achieved by presentation of historical and scientific fact; and

Whereas, Participation in the arts may improve confidence, social skills and learning skills and troubled children who participate in art programs are more likely to continue their education and adopt appropriate social behavior; therefore

Resolved, That the General Federation of Women’s Clubs – New Hampshire urges that arts in the broadest sense be integrated into curricula of preschools, elementary schools, and secondary schools, and as many aspects of community life as possible; and further

Resolved, That the General Federation of Women’s Clubs – New Hampshire urges its member clubs to encourage promotion and funding for all the arts, both visual and performing, in schools and communities.
