Proposed amendment to the GFWC-NH Bylaws

ARTICLE II Section 10.

Currently reads:

“Federation officers shall be elected by ballot in the even numbered years to serve for a term of two (2) years or until their successors are elected.”

Proposed to insert the following words after the word “elected”

“In the event that there is only one nominee for each office, the President may declare the nominees elected by Acclamation or by General Consent.”

If adopted will read:

“Federation officers shall be elected by ballot in the even numbered years to serve for a term of Two (2) years or until their successors are elected. In the event there is only one nominee for each office, the President may declare the nominees elected by Acclamation or by General Consent.”
